### PAYMENT PLAN

### PAYMENT POLICY

Once the tuition amount is determined, our payment policy is as follows:

1. Students will *not* be re-admitted following winter or spring break unless tuition is current.
2. All tuition is to be paid in full by **April 15, 2018**.
3. Neither your student's report card nor transcript will be distributed until all accounts for your family are paid in full.
4. If there are changes in your financial circumstances which impact your family's ability to pay, you are requested to make an appointment with the Director of Business and Human Resources as soon as possible.
5. An account which continues to be delinquent will be turned over to a collections agency.

In consideration for enrollment, I agree to pay the contracted tuition:

1. I understand that the tuition as stated does not include incidental expenses including, but not limited to lunch, lost book fees, and special field trips.
2. I understand that I have an unconditional obligation to pay the tuition for the full academic year after the acceptance of this contract by the N.E. Miles Jewish Day School.
3. I understand that if payment is not made when it is due, late charges as outlined on the previous page will be assessed. The payment of those additional charges is my responsibility.
4. The school reserves the right to withhold my student's final grades and transcripts until I have met all the financial obligations to the school.
5. The school reserves the right to prohibit my student from attending if I have not paid charges according to the terms of this contract, including having a current account when school resumes after winter & spring breaks.
6. I understand that if our family is receiving tuition assistance, we are responsible for all tuition, fees and expenses in excess of the tuition assistance awarded (including, but not limited to lunch, lost book fees, and special field trips).
