

## TUITION INFORMATION

Tuition for the **2018-2019 school year** is **\$10,750** and does not include special grade-level field trip fees, school shirt costs, technology fees, lost book fees, and other optional fees including lunch fees, Parent Association dues, and after-school activity costs.

### Tuition Deadlines

**February 6, 2018: Early Bird Tuition Deadline**

Tuition: \$10,600 per student  
Non-refundable Registration Fee: \$350 per student (applied to tuition)

**February 20, 2018: General Tuition Deadline**

Tuition: \$10,750 per student  
Non-refundable Registration Fee: \$350 per student (applied to tuition)

**After February 20, 2018: Late Tuition Deadline**

Tuition: \$10,750 per student  
Non-refundable Registration Fee: \$350 per student (applied to tuition)

**Late re-enrollment fee: \$250 per student (non-refundable)**

## **TUITION ASSISTANCE:**

**All tuition assistance requests must be completed and filed by March 16, 2018.**

All families requesting tuition assistance must use FACTS - an independent agency designed to assess ability to pay for private school education. Applications are reviewed anonymously by the Tuition Assistance Committee. Tuition assistance recipients are responsible for all tuition, fees, and expenses in excess of the assistance awarded.

1. Go to our website, click on admissions, then click on tuition and financial aid.
2. Forms must be completed on line with the latest tax year documents and a processing fee.
3. No consideration for tuition assistance will be made unless application to FACTS is completed and all required documentation to FACTS has been submitted along with your completed Enrollment Form and \$350 Registration Fee paid in full.
